The story started early in the autumn when I happened to be out cutting my lawn as a couple with their 11 year old daughter went by on an afternoon walk. I had noticed them before around the neighborhood as Melissa, the daughter, was in a motorized wheelchair and used a keyboard to communicate. It turned out that she had cerebral palsy, a malfunction of the motor centers of the brain due to damage to the tissue that results in a lack of muscular coordination, resulting in speech and movement problems.

It's Almost Here

The first race is scheduled for January 6/7, and it looks like it will be a good one. There will be an extended happy hour back at Chums (next to the Desert Inn) with a weenie roast and bonfire from about 4:30 to ??? They'll be serving jambalaya for dinner along with mulled beers by the fire. Maybe even some fireworks. The third weekend (Feb 3/4) there will be a 2 hour Enduro on Saturday and hopefully a party at the hall with buffet dinner. As with all racing these days, help is scarce. Ice Racing is no exception, they need you!!!! It doesn't have to be every weekend, even just 1 or 2 would be a help. Don't like the cold? How about timing and scoring! Never seen Ice Racing? You ain't seen nothin' yet!!!!!

One of the big factors in Ice Racing that makes it so good is the social aspect. The workers and volunteers are treated like GOLD!!! Worker rooms for free. Hot lunches at the lake (also free). There is no us and them attitude, drivers and workers and crews are all one big family. If you feel so inclined; they have the occasional worker race, where you drive their race cars. The club has re-acquired their media car, so if you wanted to try a novice race or possibly a senior race, contact Lorne Stead. Do you just want to go for a ride at lunch? Just ask!!! I used to race a 4WD Subaru with a 200+ HP Mazda rotary engine and I would love to take people for rides and scare the s...... wait a minute that's not what I meant to say. I used to love taking people for rides and seeing the expressions of joy and exhilaration after a really good lap!!!!!! Yah that's it!!! Flat out in 4th gear, 100+ MPH (remember, we're on ice here) pitch the car sideways and go flat out through the sweepers and kinks. Awwww memories!!!!! If you've never been up to the Ice Races, here's the unofficial and no doubt incomplete lowdown. All races are subject to weather conditions. Before you go, call the hotline to see if the races are still on. It takes about $4\frac{1}{2}$ hrs to get to Cache Creek (the Desert Inn is the Ice Race Headquarters). Call and let them know you would like to stay in the worker rooms. If they don't get any requests, they may rent them out to paying customers. The Fraser Canyon can be a little nasty at times, but the races are almost always finished early enough on Sunday so you can get through the canyon in daylight. If you've ever been to Whistler skiing, it's not much different. Just less traffic. If you go up Friday night the usual 'meeting place' is the pub in the Oasis hotel. Directly across from the Desert Inn. Drivers, crews, workers all meet there. After all, it is Cache Creek, what else are you gonna do!!!! There isn't a typical 'morning meeting' as at Mission, but there is always a 'drivers meeting' in the morning, and that usually signals that things are ready to go. Drivers meetings are typically between 9am and 10am. The lake is about 20-25 minutes from the motel. Go south on HWY 1, then left towards Ashcroft, cross the bridge into Ashcroft, stay on the main road, cross the RR tracks then up the hill out of town towards Logan Lake, 5-10 minutes up the road turn left onto Barnes Lake road, another 3-5 minutes and you're there. I won't try to kid you, it can be cold and windy up there, but if you've ever been skiing you'll be OK. Most important thing is warm boots (not steel toed, they freeze). I've been up there many times in just a T-shirt, jeans and boots. Typically they only use 3 flags; yellow, red, and debris, sometimes they use blue but not always. There should be at least 2 people per turn, if not, make some noise and they'll find someone. Your helper will most likely be a second driver or a crewperson. Don't be surprised if a race car stops at your turn on the cool off lap. He maybe picking up your helper to switch drivers or change tires, etc. Someone will come back, if they don't, get on the radio and make some noise, they'll find someone. As always safety is the number one concern. If you don't like your turn location? Move it!!! Remember, you're on a frozen lake, where you stand is where the flag station is located. Number two concern behind safety is to have fun. Where else do they have a mandatory happy hour on Saturday night.

Vancouver Indy race set to motor off to Montreal By Gordon McIntyre

Unless there's a dramatic reversal, the Molson Indy Vancouver will end its 12-year run next Labour Day weekend. After that, it will be moved to Montreal, as has previously been reported in *The Province*.

Three things hold back an official announcement: The race's sanctioning body, Championship Auto Racing Teams, has been without a president and CEO for almost six months; the City of Montreal hasn't given official approval; and sponsor Molson has to weigh the cons of pulling out of the Lower Mainland an event that has an economic spin-off of \$26 million and attracts more than 150,000 people.

"It's no secret negotiations are continuing with Montreal (for 2002 and beyond)," Stu Ballantyne, general manager of the Vancouver Indy, said yesterday. "But there's no formal agreement. A whole lot of things have to be lined up before there could ever be a deal."

Two promoters — one favouring downtown streets, one the permanent Circuit Gilles Villeneuve — want a CART race in Montreal, which already hosts a Formula One race each June.

But Molson holds the right to match any offer made for a Canadian race.

CART is adamant it has room for just two Canadian races in its 22-race schedule.

"We've said in the past we're interested' (in hosting a CART race) and we have nothing new to announce," said Normand Prieur, a spokesman for the Air Canada Grand Prix. "It's a Molson decision."

Asked how much lead time the Grand Prix_people would need to put on a CART race,' Prieur said: "We're not considering that as we speak right now. June 8, 9 and 10 (the dates of the F-1 race) are what concern us right now." Most race teams love coming to Vancouver, but the everchanging False Creek course — because of encroaching development — is always a concern to CART. As well, Molson has to negotiate with seven landlords for use of the site, including the city and Concord Pacific.

"What will happen between now and 2002?" Ballantyne said. "I don't know where CART is heading, there are so many factors up in the air. Right now, Molson is committed to 2001 in Vancouver."

If Molson is to retain the rights to two CART races in Canada, it must match the five-year offer that's been tendered for a Montreal race (by Gerry Forsythe, co-owner of the Player's team Greg Moore drove for) or find a way to keep a race in the Lower Mainland for the long term.

Symphony of Fire goes up in smoke By Gordon Clark

Vancouver's growing reputation as Dullsville became further entrenched yesterday with Benson & Hedges decision to quit funding the annual Symphony of Fire fireworks competition. The likely cancellation of the world-renowned summertime event — the city's largest annual public get-together — comes not long after the city learned that the Molson Indy will likely leave town for Montreal after Labour Day.

Benson & Hedges spokesman John McDonald said new federal rules regarding tobacco advertising made it impossible for the company to continue paying about \$2 million each year for the massively-popular fireworks show. "We are very sad," he said. "It is a very sad day for our company and the city of Vancouver when you consider approximately 1.5 million people watch the fireworks each year in Vancouver."

Benson & Hedges also pulled Its cash from the Vancouver Film Festival, and the film festivals and Symphony of Fire shows it backs in Montreal and Toronto.

At issue is Ottawa's decision to ban tobacco companies, beginning last month, from putting their trademarks on off-site advertising for events they sponsor. The Vancouver Film Festival was hit by that rule this year.

By 2003, tobacco firms will be barred outright from sponsoring the events, something that will be fought in court, said McDonald.

"It doesn't take a rocket scientist to realize that people don't begin to smoke, or continue to smoke, because of the sponsorship," he said.

McDonald said Tourism Vancouver calculated that the Symphony of Fire brings \$13 million into the city each summer.

Vancouver Symphony of Fire organizer Ray Greenwood said "the event is dead" without a major new sponsor.

Greenwood said he is hoping a financial institution, communications company, high-tech firm or any other major group will come forward and sponsor the event.

In August, Greenwood predicted the end of the event if Ottawa didn't back off its new anti-smoking rules. But he said yesterday's announcement still came as a shock.

He said Benson & Hedges should be thanked by Lower Mainland residents for pouring millions into the event over the 11 years the company sponsored it.

But he said he understood the company's decision to quit paying for the event since it can't advertise its support. An estimated 1.3 million people viewed the Symphony of Fire over four nights in August. Greenwood told people in August to lobby their MP's if they want the show to remain.


